Tuition Payment Schedule:

(\$25 late fee will be added to all payments received after the 10th of the month. NO EXPECTATIONS.)

Class tuition fees are based on 10 months (40 classes), payable in 9 months.

September and June tuition are due at registration.

ALL PAYMENTS ARE DUE BY THE 1ST OF THE MONTH.

Costume deposit of \$25/per costume will be billed in November, payable in December. Remaining costume balance will be billed in February.

Yearly Registration Fee is \$20 per family, due at the time of registration.

Registration Fee & Tuition payments are non-refundable.

If a student decides to withdrawal from classes, a minimum of one-month notice is required or payment is your responsibility.

Please read the following carefully. This must be signed and returned.

Parent Release:

- I understand dance, acrobatics, and exercise involve some risk, therefore, I, the undersigned do hereby expressly release and waive any and all claims, demands, and actions against Stephen W. Hadala and Kathryn M. Short or Great Lakes Dance Centre, for any and all injury, loss or damage, whatsoever sustained as a result of my child's participation in the dance, acrobatics or exercise classes of Stephen W. Hadala, Kathryn M. Short, or teachers associated with or representing them or Great Lakes Dance Centre.

Great Lakes Dance Centre Policies:

- Tuition is due no later than the 10th of every month. All Payments made after the 10th will be subject to a \$25.00 late fee, no exceptions. In the event tuition is delinquent by two or more months, the student will not be allowed to participate in class, rehearsals, performances, competitions, or any event affiliated with Great Lakes Dance Centre. Costumes for the annual showcase will not be ordered for any student who is delinquent in tuition payments. If a student registers for classes mid-month, tuition will be prorated for that month only. Classes missed due to illness, vacation, or school activities will not be prorated. Make-up classes will be available.
- If you would prefer to make a payment for the entire year, in advance, a 10% discount will be applied to the account.
- Classes are divided by age, however, students may be placed in a higher or lower level. This decision will be solely based on faculty discretion.
- Appropriate dance attire is expected for all classes and rehearsals (please see class dress code). Hair must be pulled back from face, and in a bun for all intermediate and advanced level ballet classes. Students must have proper footwear for all classes.
- No food, gum chewing, or drinks are allowed in the dance studios; only water is allowed.
- No cell phones permitted in the studio at any time.
- Attendance is mandatory for all classes and rehearsals. If a student must be absent, please contact the studio via telephone, email, or Facebook. Excessive absences will jeopardize the student's involvement in all performances and competitions. Make-up classes are available for missed classes.
- Students who will be arriving late for class, must notify the studio in a timely fashion. When the student arrives, they must wait outside the studio door until the instructor permits them to enter.
- Great Lakes Dance Centre believes that our students and their family members are ambassadors for the studio. We encourage all to post, and re-post videos, pictures, and comments on social media. However, posting negative comments about Great Lakes Dance Centre, the faculty, or others students is prohibited. The first time a student or a member of their family violates this rule, they will be warned and unable to take class for a week. If the same student or a member of their family posts negatively for a second time, they will be excused from any further association with GLDC.
